**CLIENT REPRESENTS THERE IS:**

(1) There is parking within 50 feet for attendant and equipment (2) Good access to the booth setup area (3) A 120v electric outlet within 15 feet of the desired booth(s) location; (4) That the client will be responsible for any negligent or intentional damage done to the photo booth by Client or any of the Client's guests; (5) The photo booth will be set up indoors or completely covered by a tent or other structure. The booth will not operate exposed to the elements; (6) A table is provided for any props/scrapbook that the customer will have at the event. Cool Cube Photo Booths will not provide a table for the event.

**RENTAL AGREEMENT:**

Cool Cube Photo Booths agrees: (1) to provide a photo booth that does not require money to operate and to provide sufficient film and supplies for the duration of use for the event; (2) to provide a qualified technician to operate the photo booth during the event. Client and Cool Cube Photo Booths agree that in the event of a mechanical failure or for any reason or inability to perform such that Cool Cube Photo Booth cannot provide functioning photo booth, that Cool Cube Photo Booths maximum liability is the return of any payments received. If only partial services can be provided due to conditions beyond Cool Cube Photo Booth's reasonable control then the charges are to be prorated. (3) To have the photo booth operational for a minimum of 80% of the agreed on times, occasionally operations need to be interrupted for maintenance of the photo booth (changing paper, adjusting the camera, addressing technical issues, ECT.)
